

Luxembourg investment funds have a wide array of parties involved in their operation. EFG Fund Services is able to perform a variety of functions to support fund activities.






Supporting your AIF from the start

The following practical steps are typically required to create a Luxembourg AIF:

- Coordination with lawyers, auditors and other service providers.
- Participation in reviewing the Fund's documentation (Prospectus, Articles of Incorporation, etc).
- Guidance on safekeeping requirements for financial and non financial assets.

Depositary bank

- Safekeeping of financial assets.
- Ownership verification of non-financial assets.
- Extended due diligence control of non-financial assets (onsite visits of free-ports, vaults, art galleries, assessment and control of storage facilities).
- Oversight duties such as compliance on investment, regulatory restrictions, valuation of assets and control of delegated activities.
- Cash flow monitoring.
- Ensuring that transactions are settled in compliance with the rules applicable to the market where the transaction is executed.

Transfer agency

- State-of-the-art transfer agency system.
- Maintenance of shareholder records.
- Due Diligence on investors, ensuring compliance with KYC and anti-money laundering requirements.
- Processing of subscriptions. redemptions, conversions and share transfers.
- Issue and follow up of commitments, drawdowns and uncalled commitments.

- Processing orders via Clearstream (Vestima +).

Paying agent

- Provide registered office for the AIF and associated Luxembourg entities.
- Safekeeping of corporate documents.
- Filing of tax returns, other statutory notices and other communications.
- Corporate secretarial services with respect to board meetings.
- Preparation and dispatch of investor notices.
- Provision of physical premises to host board and other meetings.

Luxembourg Stock Exchange listings

Able to assist AIFs with their initial listing application on the Luxembourg Stock Exchange ("LuxSE") and ensure that all continuing LuxSE obligations are adhered to.

- Admission to the Luxembourg Stock Exchange.
- Verification of the eligibility of the fund's shares in a recognized system by the LuxSE.

Central administration and accounting

- Maintenance of the accounting of the AIF.
- Preparation and distribution of annual financial statements in accordance with Luxembourg GAAP or IFRS.
- Co-ordination of the audit of annual financial statements.
- Preparation of the AIF's financial reporting to the Luxembourg authorities.
- Preparation of AIF periodic net asset value and reporting to investors.
- Calculation and preparation of the subscription tax ("Taxe d'abonnement").

- Access to additional funds for future growth.
- Provide additional comfort for investors.
- Enhance issuer's visibility and transparency of financial information.
- Provide eligibility for institutional investors.
